**Note for Barristers & Solicitors.**

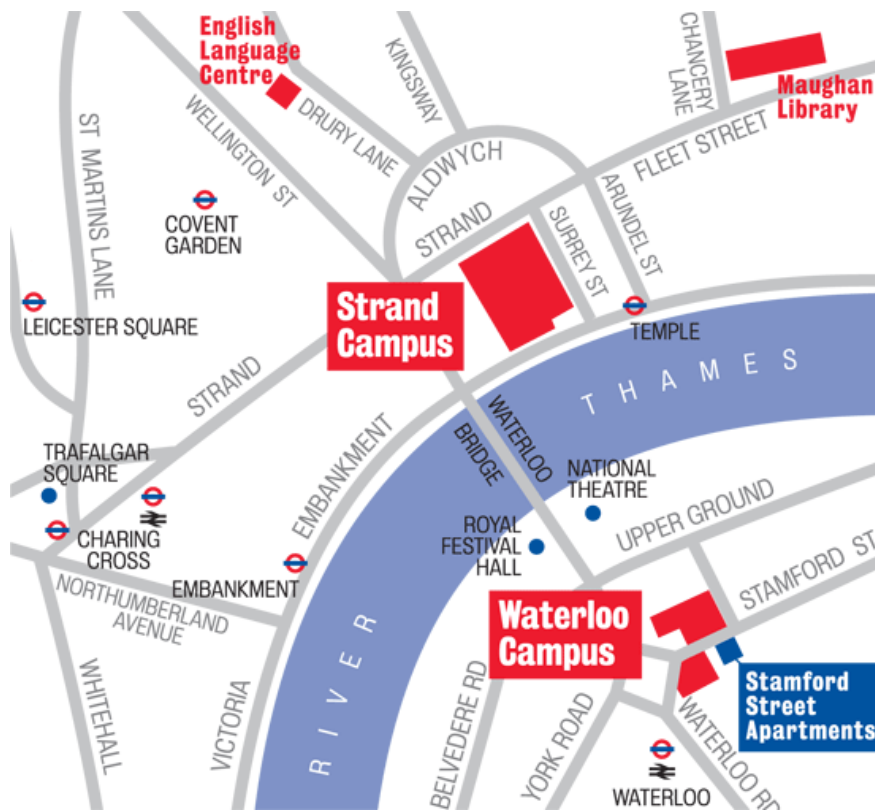
